2. His appointment to the service shall be subject to the following terms and conditions: -

- i. He shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servant (Appointment, Promotion & Transfer) Rules, 1989, Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011, Khyber Pakhtunkhwa Government Servants conduct Rules 1987 and any other Rules and instructions which may be issued by the Competent Authority from time to time.
- ii. He shall be allowed the minimum pay of BPS-16 plus other allowances as admissible under the rules.
- iii. He shall be governed by such rules and instructions relating to leave, T.A. and Medical Attendance as may be prescribed from time to time.
- iv. He shall be on probation initially for a period of one-year extendable upto two years.
- v. He shall be eligible for continuous and eventual confirmation in the post on satisfactory completion of the



probationary period, subject to availability of permanent post.

- vi. His services shall liable to be dispensed with at any time without notice and assigning any reason before the expiry of the period of his probation/extended period of probation, if, his work or conduct during this period is not found satisfactory. In the event of termination from services, fourteen days' notice or in lieu thereof fourteen days' pay will be paid by the Government. In case of resignation, he will give one-month notice to the Competent Authority or in lieu thereof one month pay shall be forfeited to the Government. The resignation shall, however, be subject to the acceptance by the Competent Authority.

3. If the above terms and conditions of appointment are acceptable to him, he would report for duty to the undersigned immediately. The offer of appointment shall be deemed to have been cancelled if any one fails to report for duty to the undersigned within one month from the date of issue of this order.

4. He will join duty on his own expenses.


