- 2. His appointment to the service shall be subject to the following terms and conditions:
 - i. He shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servant (Appointment, Promotion & Transfer) Rules, 1989, Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011, Khyber Pakhtunkhwa Government Servants Conduct Rules 1987 and any other Rules and instructions which may be issued by the Competent Authority from time to time.
 - ii. He shall be allowed the minimum pay of BPS-14 plus other allowances as admissible under the rules.

In case of resignation, he will give one-month notice to the Competent Authority or in lieu thereof one month pay shall be forfeited to the Government. The resignation shall, however, be subject to the acceptance by the Competent Authority.
